7. I understand that CKR makes no representations or warranties, expressed or implied, about the animal's health. CKR will in no way be responsible for any health problems that may arise. I furthermore agree to care for the animal should he/she develop a health problem, and I understand that veterinary care can be expensive.

CKR recommends that adopters exercise prudence, caution and patience when introducing an animal into a new environment. CKR is available to assist with introduction and/or any adjustment issues.
